## **Medicaid Health Plans of America Names Craig Kennedy as New CEO**

**WASHINGTON, D.C. (September 24, 2019)** – Medicaid Health Plans of America (MHPA) has named health policy and advocacy expert Craig Kennedy as its new Chief Executive Officer.

Kennedy brings broad experience with health care providers, public health organizations, and health advocacy combined with work in legislative affairs for both the U.S. House and Senate to MHPA. He most recently served as executive director of the Association of Clinicians for the Underserved (ACU). Kennedy is also President of the Coalition for Health Funding and serves as a board member of the Partnership for Medicaid, the largest coalition of providers and health plans dedicated to protecting and improving the Medicaid program.

While at the Association of Clinicians for the Underserved (ACU), Kennedy established the policy and advocacy infrastructure for the organization’s top priorities, including “Medicaid: Making a Real Difference,” and the “Campaign to Strengthen the National Health Service Corps.” He also increased total annual revenue each year, setting organizational records in 2017 and 2018.

Before his time with ACU, Kennedy spent more than a decade with the National Association of Community Health Centers, serving as Director of Public Health Policy, then Director of Federal Affairs and finally as Associate Vice President. He also held numerous staff positions on Capitol Hill, including serving as the Legislative Director for a member of the House Rules Committee.

Kennedy holds a Master of Public Health from George Washington University and a Bachelor of Science degree in Computer Science from Willamette University.
