New Chair, Vice Chair Appointed to MHPA State Affairs Committee

WASHINGTON, DC – Danielle Pavliv, director of state public policy, at Humana and Stephen Cozzo, vice president, government relations and external affairs/public policy at AmeriHealth Caritas are the new Chair and Vice Chair, respectively, of the Medical Health Plans of America's (MHPA) State Affairs Committee.

MHPA's State Affairs Committee is responsible for the identification, development, and management of key Medicaid and managed care issues at the state level, as well as building strategic relationships with state health plan associations. Pavliv and Cozzo will work closely with MHPA's Director of State Affairs Stephanie Myers on activities and initiatives that directly impact state Medicaid programs and Managed Care Organizations (MCOs).

Prior to Humana, she worked for Health Management Associates (HMA), where she collaborated with a range of clients across the health care spectrum to conduct policy analysis; project management, planning, implementation, and evaluation; market analyses and strategy; and RFP development, writing and review.

As vice president for government relations and external affairs/public policy for AmeriHealth Caritas, Cozzo leads a team of Public Policy experts with a focus on the identification of political and economic contingencies, evidence-based policy research, policy thought-leadership, and

future trends in public health care. Prior to his time with AmeriHealth Caritas, he worked with the First Judicial District of Philadelphia, serving at-risk youth.
